## Village of Westover Electric Issues

There have been numerous electrical outages in Westover this past year. The Westover Board has been in touch with Michael Gossert, Hampden Township Manager, who let us know that he is working hard on our behalf to get this corrected. The problem stems from the underground wiring which is starting to deteriorate and the switching equipment which is getting older. PP&L is fully aware of the situation and has been reacting to the outages.

We would like PP&L to be proactive, however, and replace all the wiring that is

failing rather than providing a patchwork job as situations come up for repair. Needless to say, the cost of total replacement is great and PP&L is allocating resources as they see fit.

As Westover residents, we need your help. Hampden Township needs emails, letters, documentation and support information to take to PP&L to get them to move on this project. The more documentation they have the better position they are in to help pressure PP&L to get this done soon.

Our Westover Webmaster, John Coyne, is developing a web form for you to report any outages with the date, time, address, duration and any impact that the electrical outage had on you. You can also go to the Village of Westover website at [www.villageofwestover.org](http://www.villageofwestover.org) and send a note to us with any helpful stories of what the electrical impact has had on you or your family. We need this information; your help would be appreciated and lead to positive results.

## PAWA Water Update

Pennsylvania American Water finished the water pressure increase on the West Shore on Wednesday, July 22. However, this has caused several problems for some homeowners. While the Westover Civic Association has no jurisdiction or influence on this matter, we can provide you some information.

**PRESSURE REDUCING VALVES**

We have received many questions regarding pressure reducing valves and find that many homeowners have already installed them. Below is some information from the PA American Water's web-site that may be of interest to you:

**Q. Will Pennsylvania American Water install a PRV for me at no charge?**

In areas where pressure is being increased as part of this project, the company will install a PRV free of charge when water pressure at an individual's property is 125 psi

or higher. For customers with pressure lower than 125 psi, their water service falls within normal operating pressures, so the decision and responsibility for installing a PRV is the homeowner's.

**Q. What if a customer experiences property damage during the pressure increase?**

If the water pressure at your property equals or exceeds 125 psi during the pressure increase in the affected areas, then for a 90-day period following the completion of the increase, Pennsylvania American Water will provide and pay

### **FOR YOUR SAFETY....**

Sergeant Shissler tells us that vandals were at work in Kings Arms once again, this time damaging street signs. He asks everyone to report (do not try to apprehend the vandals) any suspicious activity to 911 right away.

for a contractor to repair any damage that occurs to the customer's private service line up to the outside foundation of the building. In addition, if the water pressure at your property equals or exceeds 125 psi during the pressure increase in the affected areas, then for a 90-day period following the completion of the increase, Pennsylvania American Water will provide and pay for a contractor to repair damage that occurs to the customer's internal water pipes and any water damage caused by leaking water pipes. This protection does not include damage to plumbing fixtures and appliances, such as hot water heaters, clothes washers, dish washers, faucets or shower heads. The company will file a claim with its insurer for consideration of the damages listed above. As previously stated, the company will arrange for the installation of a pressure reducing valve free of charge at an individual's property, if the pressure equals or exceeds 125 psi as a result of the pressure increase.

### **Q. How do customers file a claim to be reimbursed for property damage related to the pressure increase?**

Contact Pennsylvania American Water at 1-866-641-2179 if you experience property damage that you believe is associated with the pressure increase. When you call this number, please provide your name, address and phone number, and explain the severity of the problem and whether the water has been shut off. Pennsylvania American Water will dispatch contractor crews to assess the situation, assist with cleanup, and file a claim with the company's insurance carrier for consideration of the damages

## York Waste Eligible Recycling Items

York Waste, Westover's Waste and Recycling Hauler under Hampden Township, has updated the list of eligible recycling items. The following can now be placed curbside

### Recycling Container:

- Aluminum food and beverage containers (please rinse; labels do not have to be removed)
- Plastic containers with symbols 1 through 7
- Glass (clear, brown, green) food and beverage containers (please rinse and remove lids;

labels do not have to be removed)

- Food cans (please rinse; labels do not have to be removed)

Bundle or place the following items in **Paper Bags**:

- Corrugated cardboard - please flatten and cut into pieces no larger than 3 feet by 3 feet and bundle.
- Empty aerosol cans
- Newsprint, including slick inserts
- Construction paper, cereal and food boxes, paper towel rolls or similar
- Printer paper, computer paper, copy paper
- Junk mail
- Magazines and catalogs
- Telephone books

If your recycling container is too small or broken, you can obtain a new one at the township office or by calling the number below.

When a street light bulb burns out or the pole is damaged in Westover, it is the responsibility of a homeowner to report the problem so that the proper authorities are notified to correct the situation. It is very easy to report the problem, according to the township. A homeowner should go to [www.slout.com](http://www.slout.com) which will guide you through the process of identifying the pole number and reporting what is wrong. The pole number can be found on the actual pole. To the right is a copy of what the web-site page looks like.
